The functions of the Committee shall be as under:-

- (i) Review & monitor progress of the Prime Minister's New 15 Point Programme.
- (ii) To consider & recommended to Ministry of Minority Affairs, Government of India, New Delhi the proposals under the Multi-Sectoral Development Plans for the Minority Concentration Blocks.
- (iii) Review & monitor the implementation of the progress Multi-Sectoral Development Plans for the Minority Concentration Blocks.
- (iv) Ensure that quarterly progress reports on Prime Minister's New-15 Points Programme & Multi - Sectoral Development Plans for Minority Concentration Blocks are sent to Ministry of Minority Affairs, Government of India by the 15th day of the next quarter.

The Committee will meet at least once in a quarter.
