The 06th January, 2018

No. 34 –SW(4)-2018.- In supersession of the earlier Notification No.618-SW(4)-2011, dated 30.08.2011 (which was valid upto 31.03.2017) and 468-SW(4)-2017,dated 18.05.2017/ 27.06.2017. The Council of Ministers in its meeting held on 27.09.2017 has decided to start a new scheme to be called “Dr. Syama Prasad Mookerjee Durghtana Sahayta Yojana with retrospective effect from 01.04.2017, by superseding the earlier State scheme notified on 18th may, 2017. The scope of coverage under the new scheme will be limited to those Haryana domiciles and residents of Haryana who are/were not able to avail the benefit under Pradhan Mantri Suraksha Bima Yojana whether due to non enrolment or otherwise . The benefit admissible under the “Dr. Syama Prasad Mookerjee Durghtana Sahayta Yojana” will be Rs. 1.00 lakh.”

1. THE SCHEME

Dr. Syama Prasad Mookerjee Durghtana Sahayta Yojana will be an accident insurance scheme offering accidental death and disability cover for death or disability on account of an accident, superseding the earlier State Government Notification No. 468-SW(4)-2017 dated 18th May, 2017. It shall come into force with effect from 1st of April, 2017, after the cessation of the Rajiv Gandhi Pariwar Bima Yojana which ceased on 31st March, 2017.

The Scheme is completely free of cost and no premium or consideration of any kind will be payable by the eligible beneficiaries. For the purpose of this scheme, an accident is a sudden, unforeseen and involuntary event caused by external, violent and visible means.

2. SCOPE OF COVERAGE

(i) Any person in the age group of 18 to 70 years having domiciled and resident of Haryana is eligible under the Scheme, provided the person was not enrolled at the time of accident under the Pradhan Mantri Suraksha Bima Yojana (PMSBY).

- (ii) Death/ Permanent Total Disability/ Disability due to accidents like:
- (a) Rail/Road/Air accidents;
 - (b) Riot, strike and terrorism;
 - (c) Snake bite, drowning;
 - (d) Poisoning, electrocution;
 - (e) Falling from height, collapse of house/building;
 - (f) Fire, Explosion, Implosion;
 - (g) Murder;
 - (h) Attack by animals;
 - (i) Stampede and suffocation etc;
 - (j) Frost bite, sun burn (loo), lightning;
 - (k) Burn Injuries;
 - (l) Hunger/Starvation (death only);
 - (m) Maternal Mortality during child delivery (death only);

(iii) Death/Permanent Total Disability/Disability caused due to occupational hazards like threshing machine/industrial machine etc. or due to any other unnatural events, except following:

(A) from-----

- (a) War and allied perils,
- (b) Nuclear risks,
- (c) Self-injury, suicide or attempted suicide, or

(B) whilst---

- (a) Under the influence of alcoholic drinks or drugs,
- (b) Engaging in aviation activities other than travelling as a passenger,
- (c) Breaching any law with criminal intent.

3. BENEFITS

The benefit is admissible @ 50% of the benefit admissible under Pradhan Mantri Suraksha Bima Yojana which is detailed as below:

a) Accidental Death	Rs.1,00,000 /-
b) Total and irrecoverable loss of both eyes or loss of use of both hands or feet or loss of sight of one eye and loss of use of hand or foot due to accident.	Rs.1,00,000 /-

In case of disability, the benefit will be paid to the accident victim. In case of death, the benefit will be paid to the eligible relative of the deceased as per following order of priority:

- (i) Surviving spouse (if not re-married)
- (ii) All unmarried children in equal share
- (iii) Mother;
- (iv) Father.

The benefit will not be admissible to any other person.

4. CLAIM PROCEDURE

Application will be made by the accident victim or the eligible relative (in the case of death) to the District Social Welfare Officer of the district where the accident victim resided at the time of accident. The District Social Welfare Officer will process and put up the claim within five working days from the date of receipt of claim in his office to the Deputy Commissioner. Thereafter, Deputy Commissioner will also decide the claim within five working days. The competent authority to approve the claim will be the Deputy Commissioner of the district. Appeal against the decision of the Deputy Commissioner shall lie to the Director, Social Justice & Empowerment. The time limit for filing appeal is three months from the date of order of rejection of the Deputy Commissioner.

The amount will be paid directly into the Bank Account of the eligible claimant.

5. DOCUMENTS TO BE SUBMITTED IN CASE OF CLAIM:

(I) IN THE CASE OF DEATH:

- a) Claim Form
- b) Haryana Domicile Certificate and proof of residence in Haryana State issued by the competent authority
- c) Age proof of accident victim
- d) Aadhaar Card of accident victim and eligible relative (in case of death)
- e) Copy of First Information Report or Police Daily Dairy Report

f) Post-mortem Report and Death Certificate

g) In case the surviving spouse is claimant

An affidavit that he/she is not re-married

(II) IN CASE OF DISABILITY:

a) Claim Form

b) Haryana Domicile Certificate and proof of residence in Haryana State issued by the competent authority.

c) Age proof

d) Aadhaar Card

e) Medical Certificate and Medico-legal Report issued by the competent authority confirming percentage and kind of disability.

NOTE:

1) No claim will be entertained if submitted 6 months after the date of death or 12 months after the date of accident, whichever is earlier.

2) For claims arising due to accidents occurring between 01.04.2017 and the date of issue of this notification, the time limit will commence from the date of issue of this notification.
