Rate of Financial Assistance

The rate of financial will be ₹ 2,500/- per month per family with effect from January, 2012.

Eligibility

To be eligible for assistance under this scheme, the maximum annual income from all sources of the displaced family from Jammu and Kashmir should not exceed ₹ 50,000/- per annum.

'Family' means the family of the applicant at the time of displacement from Kashmir. Any Sub-division of the family after displacement from Kashmir will not be recognized for additional financial assistance under this Scheme.

Tenure of Financial

The total period of financial assistance for re-settlement will be two years. However, for all existing beneficiaries. the period of financial assistance will be extended up to the month of December, 2012, in case the period of two years expires prior to this.
