No. 913 - SW(4)-2019 - In partial modification of the Social Justice and Empowerment Department Notification No. 1921-SW(3)-92 dated 24.08.1992 providing of social security to Handicapped Persons, Notification No. 1803-SW(4)-2006 dated 18.09.2006 Ladli Social Security Allowance and Notification No. 1988-SW(4)-2006 dated 20th September, 2006 Old Age Allowance, the eligibility conditions in respect of the following social security pension/allowance schemes, it is hereby notified that the benefits (pension/allowances) shall be discontinued forthwith in respect of beneficiaries against whom any FIR has been registered under anyone or more of such sections viz. Dowry Death 304-B IPC, Rape 376 IPC, Attempt to Rape 376/511 IPC, Sexual Harassment 354-A IPC, Disrobing 354-B IPC, Stalking 354 D IPC, Eve Teasing 509 IPC, Acid Attack 326-A/326-B IPC, Trafficking of Women 370-A IPC or any section of the POCSO Act, 2012 :

i)	Disability Pension
ii)	Ladli Social Security Allowance Scheme.
iii)	Old Age Allowance

Subsequently after the completion of trial, if such a person is acquitted, the beneficiary shall be at liberty to apply afresh to the competent authority for grant of such benefits.
