- a) Minimum average Turnover of Rs.1.50 Crore during the last 03 financial years. Turnover certificate issued by Regd.CA may be attached.
- b) 3 years satisfactory experience in the specific field of outsourcing services of different employees in various State Govt. department/ Public sector undertakings/Corporations/ Boards/ Autonomous bodies/ with documentary proof and satisfactory certificate from concerned State Agency.
- c) Valid labour and contractor license for the various contracts undertaken and certification from the respective state Govt. of Haryana Department.
- d) Having valid ESI/EPF/GST and PAN/TAN No. and attested copies of registration certificate may be attached.
- e) Services will be outsourced for which necessary man power will be provided by the successful bidder as per the requirement of department throughout the state.
- f) No tender will be accepted if the rate of service charges quoted by bidder is not feasible as per Govt. Instruction no. 43/5/2001-3GS-II dated 20.02.2014 and the minimum service charge rate will be calculated on the base rate of Rs.100/- and upto only two decimal points. In case the same service charge rate has been quoted by two and more technically qualified bidders than tender will be allotted through draw of lots between technically qualified bidders who have quoted the same rate of service charge which is lower than the others bidders.
- g) Statutory deductions will be made as per rules.
- h) The successful bidder will have to deposit the performance security equal to one month wages, included EPF, ESI of persons to be engaged in the shape of Bank guarantee valid for atleast 24 months.
- i) Successful bidder will pay the wages to the staff deputed by him on or before 7th day of each month and thereafter will submit monthly bill to the concerned office where the staff is deputed. The monthly bill is to be submitted alongwith copies of EPF/ESI challan alongwith copy of ECR in respect of EPF/ESI deduction of previous month. No payment will be released in the absence/non-deposit of said Challans & ECR. The office will release the payment within next 7 working day after submission of bill duly complete in all respect as mentioned above.
- j) Other documents to be submitted are mentioned in the Technical bid proforma.
