Financial Assistance to Non School Going Disabled Children less than 18 yrs. Scheme

ELIGIBILITY:

- 1. A person having physical disability in the age group between 0-18 years.
- 2. Child is not able to attend formal education, training etc. due to this disability.
- **3.** Domicile of Haryana state and should be residing in Haryana State for the last three years at the time of submission of application.
- **4.** Medical Certificate issued by the Civil Surgeon having following disabilities:-
 - (i) Mental Retardation with I.Q. not exceeding 50 or percentage of disability is 70% and above.
 - (ii) Persons with cerebral palsy.
 - (iii) Persons with Autism.
 - (iv) Multiple disability with a total permanent disability of 705 or more disabilities as defined in clause (i) of Section 2 of the persons with Disabilities, Protection or Rights and Full Participation) Act, 1995 (1 of 1996).
 - (v) Case of orthopedic disability with permanent disability of 100% which are further clarified as under:
 - a. Myhopathy
 - **b.** Paraplegic
 - c. Quadri Plegia
- 5 The applicant's close relatives and parents are not in a financial position to support him/her and the income of his/her parents, close relatives or his/her own income from all sources is less than the income as prescribed under the Minimum Wages. He/She will have to submit proof of income verified by the competent authority.

Exclusion:-

The assistance would not be given to such children who are already receiving assistance under the Scholarship, Unemployment Allowance and Handicapped Pension Schemes being implemented by the Social Justice & Empowerment Department, Haryana.

"Pension" wherever occurring in any Government notification concerning Social Security Benefit means and includes, income received or accrued from accumulated earnings, including schemes:-

- Provident Funds, or
- Annuities from any source including Commercial Banks, Financial Institution or Insurance.

BENEFITS PROVIDED:

1. Rs. 1900 /- per month w.e.f. 01.04.2021

DOCUMENTS REQUIRED:

- **1.** Age Proof:- (any one of the following)
 - (i) Birth Certificate issued by the Registrar of Birth & Death.
 - (ii) Affidavit, attested from first class Magistrate or
 - (iii) A certificate from any Gazetted officer of the State/ Central Govt.
- **2. Residential Proof** (Any one of the following self attested documents issued prior to 5 years)
 - i. Ration Card (Issued by Food & Supplies Department, Haryana)
 - ii. Voter Card of parents/Guardian (issued by Election Department, Haryana)
 - **iii.** Name of the applicant in voter's list that shows photograph of parents/Guardian (issued by Election Department, Haryana)
 - **iv.** In Case, none of above documents is available, a applicant will give self-declaration document along with any other documentary proof which will be verified by the District Social Welfare Officer.
- 3 Medical Certificate issued by the Civil Surgeon having following disabilities:-
 - (i) Mental Retardation with I.Q. not exceeding 50 or percentage of disability is 70% and above.
 - (ii) Persons with cerebral palsy.
 - (iii) Persons with Autism.
 - (iv) Multiple disability with a total permanent disability of 705 or more disabilities as defined in clause (i) of Section 2 of the persons with Disabilities, Protection or Rights and Full Participation) Act, 1995 (1 of 1996).

- ii Saving Bank account detail of the applicant with a photocopy of the passbook.
- iii Applicant should have Family I.d.

Note:- After attaining the age of 18 years, the beneficiary should automatically become eligible for handicapped pension.
