Widow & Destitute Women Pension Scheme

ELIGIBILITY:

- 1. Women should be in the age group of 18 years or above.
- 2. She should be domicile of Haryana and has been residing in Haryana for last 1 year at the time of submission of application.
- 3 Any one of the following conditions are fulfilled:
 - i. She is a widow; or
 - ii. She is destitute without husband, parents and son(s): or
 - iii. She is destitute due to desertion or physical/mental incapacity of,
 - (a) Husband in case of married women; or
 - (b) Parents in case of other women
- 4 Annual Income from all sources of the applicant should does not exceed to Rs. 2 Lakhs.

Exclusion:-

Notwithstanding the above, a woman employed any Government or Local/Statutory Body or any organization substantially financed by any Government or Local/Statutory body or who is drawing pension or family pension there from will not be eligible under the Scheme. "Pension" wherever occurring in any Government notification concerning Social Security Benefit means and includes, income received or accrued from accumulated earnings, including schemes:-

- Provident Funds, or
- Annuities from any source including Commercial Banks, Financial Institution or Insurance.

BENEFITS PROVIDED:

1. Rs. 2500 /- Per month w.e.f. 01.04.2021

1. Age Proof (Any one of the following)

- i. Birth Certificate (Issued by Municipal Committee/Corporation/Govt. Hospital)
- School Certificate showing date of birth, either 5th class or 8th class or 10th class (issued by School Education Board/any other Government/Private Education Institutions.
- iii Voter Card (issued by Election Department, Haryana)
- iv. Name of the applicant in voter's list that shows photograph. (issued by Election Department, Haryana)
- v. If any of the above documents are not available with the applicant, applicant must go to the DSWO office and write a letter to him/her, so that the District Social Welfare Officer can refer the case for medical examination to a constituted team of two doctors in the civil hospital of the district to assess the age of the applicant. (issued by the medical team)
- **2. Residential Proof** (Any one of the following self attested documents issued prior to 5 years)
 - i. Ration Card
 - ii. Voter Card
 - iii. Voter List
 - **iv.** In Case, none of above documents is available, an applicant will give self-declaration along with any other documentary proof which will be verified by the District Social Welfare Officer.
- 3. F.I.R Copy of missing person's report of the husband missing for the past 7 years.
- 4 Death Certificate of Husband (in case of widow)
- 5 Destitute Certificate (in case of Destitute Women)

6. Other Documents

- i Aadhaar Card (Optional)
- ii Saving Bank account detail of the applicant with a photocopy of the passbook.
- iii Applicant should have Family I.d.
