# Financial Assistance to Destitute Children (FADC) Scheme

# **ELIGIBILITY:**

- 1. A child under twenty-one years of age.
- 2. Domicile of Haryana and residing in Haryana State.
- 3. Children have been deprived of parental support or care by following reasons
- i Reason of Death or;
- ii Continued absence from home of his father for the last 2 years, or;
- iii Father/Mother has been sentenced to imprisonment for a period not less than one year, or;
- iv Physical/Mental incapacity of Parent

Documents in support of deprivation (any of the following documents may be furnished if required in support of being deprived).

- a Death certificate of father
- b Legal guardian certificate
- c Destitute Certificate
- **4.** Income of parents/guardians from all sources should not exceed Rs. 2, 00,000 per annum.

#### **Exclusion:-**

Notwithstanding the above, in case the guardian or any parent of the child is employed by any Government or by any Local/Statutory Body or any organization substantially financed by any Government or Local/Statutory Body or who is drawing pension or family pension there from will not be eligible under the scheme.

"Pension" wherever occurring in any Government notification concerning Social Security Benefit means and includes, income received or accrued from accumulated earnings, including schemes:-

- Provident Funds, or
- Annuities from any source including Commercial Banks, Financial Institution or Insurance.

# **BENEFITS PROVIDED:**

- 1. Rs. 2100/- Per month w.e.f. 01.01.2024
- 2. Rs. 4200/- Per month for 2 children

Note:- Benefit is admissible of up to two children in a family.

# **DOCUMENTS REQUIRED:**

- 1. Age Proof:-
- (i) A certificate from Head of an Educational or Technical Institution last attended, or
- (ii) A certificate from a Gazetted Officer of the Central or State Government personally known to the applicant; or
- (iii) An affidavit attested by a I<sup>st</sup> Class Magistrate.
- **2. Residential Proof** (Any one of the following self attested documents issued prior to 15 years)
  - i. Ration Card (issued by Food & Supplies Department, Haryana)
  - ii. Voter Card (issued by Election Department, Haryana)
  - **iii.** Voter list which shows name of the applicant alongwith his/her Photograph (issued by Election Department, Haryana)
  - **iv.** In Case, none of above documents is available, applicant will give self-declaration along with any other documentary proof which will be verified by the District Social Welfare Officer.

### 3. Other Documents

- i Aadhaar Card (Optional)
- ii Saving Bank Account detail of the applicant with a photocopy of the passbook.
- iii Applicant should have Family I.d.
