Old Age Samman Allowance Scheme

ELIGIBILITY:

- 1. Age of the applicant should be 60 years or above.
- 2. Domicile and resident of Haryana.
- 3. Annual income from all sources together with that of his or her spouse does not exceed Rs 3,00,000/- per annum.

Exclusion:-

The retirees from any Government or any Local/Statutory Body or any Organization owned and controlled by Government, who are in receipt of annuity or Pension less than the Old Age Samman Allowance fixed by the Government from time to time, shall be entitled, subject to eligibility, to Old Age Samman Allowance. The entitlement shall be equal to the difference between the sum of benefit fixed under Old Age Samman Allowance from time to time and the pension or annuity as received.

BENEFITS PROVIDED:

1. Rs. 3000 /- Per month w.e.f 01.01.2024.

DOCUMENTS REQUIRED:

1. Age Proof (Any one of the following)

- i. Birth Certificate (Issued by Municipal Committee/Corporation/Govt. Hospital)
- ii. School Certificate (5th class or 8th class or 10th class).
- iii Voter Card (issued by Election Department, Haryana)
- iv. Name of the applicant in voter's list that shows photograph. (issued by Election Department, Haryana)
- v. If any of the above documents are not available with the applicant, applicant must go to the DSWO office and write a letter for medical examination so that the District Social Welfare Officer can refer the case of the applicant for medical examination to a team composed of two doctors in the civil hospital of the district to assess the age of the applicant. (issued by the medical team)

- **2. Residential Proof** (Any one of the following self attested documents issued prior to 15 years)
 - i. Ration Card (issued by Food & Supplies Department, Haryana)
 - ii. Voter Card (issued by Election Department, Haryana)
 - iii. Name of the applicant in voter's list that shows photograph. (issued by Election Department, Haryana)
 - **iv.** In Case, none of above documents is available, a applicant will give self-declaration document along with any other documentary proof which will be verified by the District Social Welfare Officer.

3. Other Documents

- i Aadhaar Card (Optional)
- ii Saving Bank account detail of the applicant with a photocopy of the passbook.
- iii Applicant should have Family I.d.
