No. 40/03/2024-4(SW)—The Governor of Haryana is pleased to constitute a Society, namely Haryana Divyangjan Welfare Society, Panchkula, for welfare of divyangjan in the State of Haryana.

MEMORANDUM OF ASSOCIATION

Draft provision in New Society

1. The name of the Society shall be the Haryana Divyangjan Welfare Society, Panchkula.
2. The registered office of the Society shall be situated at Bays No. 53-54, Kalyan Bhawan, Sector-2, Panchkula-134109, Haryana.
- 3 (1). In this memorandum and the rules made thereunder unless the context otherwise requires :—
 - (i) 'Chairman' means the President of the Society;
 - (ii) 'Government' means the State Government of Haryana in Social Justice, Empowerment, Welfare of Scheduled Castes & Backward Classes and Antyodaya (SEWA) Department;
 - (iii) 'Institute' for the purpose of this Memorandum means Rehabilitation Centre, Urban Institute, Institute for Visually Handicapped, Intervention Programme Centre for Handicapped, Mansik Vikas Kendra, Special Schools for Mentally/ Physically challenged persons, etc. to be taken over by the Society;
 - (iv) 'Society' means Haryana Divyangjan Welfare Society, Panchkula;
 - (v) 'Vice-Chairman' means the Vice-President of the Society;
4. **Aims and Objectives of the Society:** The Haryana Divyangjan Welfare Society, Panchkula will have the following aims and objectives and shall be competent to perform the following functions :-
 - (i) to provide financial assistance to the Institutes to enable them to carry out their Schemes/ Programmes being undertaken/ to be undertaken for the welfare of the Divyangjan;
 - (ii) to provide services to Divyangjan to help them to take care of their special needs and/or to rehabilitate them as per the Scheme/Programme of the Institute;
 - (iii) to empower parents and family members and to involve them as co-therapists to carry out training programmes of Divyangjan through the Institutes;
 - (iv) to provide early stimulation and intervention training to Divyangjan and to help them to achieve speedy development through the Institutes;
 - (v) to provide vocational training to Divyangjan to enable them to achieve self

dependence;

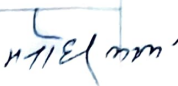
- (vi) to develop effective models of Home-based training programme suiting to the needs of Divyangjan;
- (vii) to run outreach programme to cover Divyangjan in the far-flung areas and to extend services;
- (viii) to develop human resources to provide specialized services Divyangjan;
- (ix) to organize short term courses/ conferences/ seminars/workshops and update the skills and knowledge of professionals working in the field as per the Programme/Scheme of the Institute;
- (x) to undertake any other activity for the promotion of welfare of the Divyangjan;
- (xi) to receive grants and contributions to have custody of and to expend, the fund of the Society and to manage its properties;
- (xii) to deal with any property belonging to or vested in the Society in such manner as the Society may deem fit/decide for the advancement of its objectives, provided that no immovable property of the Society shall be disposed off, in any manner whatsoever, without the prior approval of the State Government;
- (xiii) to deposit the money credited to the fund of the Society with such banks, or to invest the same in such manners, as the Society may deem fit; and
- (xiv) to perform such other functions and to carry out such other duties as may, from time to time, be assigned to it by the State Government;

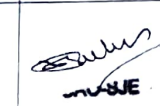
