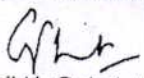

The Committee, if deemed fit, may include any other person(s) as member. However, at-least 60% members of the committee should be Academicians/others, not in Government. The Committee shall be responsible for social mobilization, IEC activities etc. at the district level so that preventive activities could take place effectively.

The Committee shall also take all appropriate action(s) for proper implementation of orders issued from time to time by Hon'ble Court in the aforementioned writ petition.

The Chairman of this Committee shall hold a meeting within one month from the date of receipt of these orders and send proceedings thereof immediately.
