No. 268/SW(4)/2016 : In pursuance of orders dated 13.01.2016 and 16.02.2016 passed by Hon'ble Punjab and Haryana High Court in Civil Writ Petition No.20359 of 2013 - Court on its Own Motion V/s State of Punjab & etc., a **District Level Coordination Committee** is hereby constituted consisting of following officers:-

The said Committee shall meet at least once in a quarter, preferably once in a month and will assess how many cases have been detected/raided by respective agencies during the month by coordinating/sharing the intelligence about drug trafficking. Committee shall submit its report to Health Department (DGHS) with a copy to DG (Social Justice & Empowerment Department), Haryana and ADGP (Crime) so that suggestion(s) given by the Committee can be implemented in public interest by the concerned departments.

The enforcement part of work of the committee will be the Enforcement of Drug De-addiction and taking action on secret information regarding illegal sale of drugs. All the "Enforcement activities" of the Committee will be kept secret and confidential and out of purview of Right to Information Act insofar as they refer to drug trafficking/illegal activities related to drug traffickers/and at the rehabilitation centres so as to prevent access by Drug Mafia/traffickers. The proceedings pertaining to Enforcement shall be sent, in a sealed envelope, to the Administrative Secretaries of Home, Health, Excise & Taxation, Education and Social Justice & Empowerment Department so that they are aware of the developments in the field.

The Committee shall also take all appropriate action(s) for proper implementation of orders issued from time to time by Hon'ble Court in the aforementioned writ petition.

The Chairman of this Committee shall hold a meeting within one month from the date of receipt of these orders and send proceedings thereof immediately.
