2. The functions of the Committee will be:-

- a. Formulating a State Campaign Activity including in districts covered under Nasha Mukh Bharat.
- b. Ensuring implementation, formulation and implementation of the district campaigns including in districts covered under Nasha Mukh Bharat.
- c. Guiding and overseeing the implementation of district campaign in identified vulnerable districts of the State.
- d. To increase community participation and public cooperation.
- e. Conducting training programs for the service providers at State Level, district level and below district level.
- f. Having a social media strategy for the State campaign and implementation of the same.
- g. Visit to the institutions, hospitals and affected places.
- h. Ensuring strict implementation of ban on sale of cigarettes within 100 meters of any educational institution.
- i. Obtaining information on the availability/sale of drugs and review the action taken on such information.

3. The Governor of Haryana is further pleased to order that the 'State Level Committee for Prevention of Substance Use' shall function as 'State Level Nasha Mukh Bharat Campaign Committee' in districts covered under the Nasha Mukh Bharat Campaign.
