Dated Chandigarh the 28th May, 2021

No. 269-SW (4)-2021. Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India launched a crowd sourcing mobile application **"Sugamya Bharat APP"** for **'Jan-Bhagidar'** on 02nd March 2021 for enabling citizens including Divyangjan, Senior Citizens, Pregnant Women, Children and those that are temporarily disabled owing to illness, surgery or post-trauma etc. to register grievances/issues related to accessibility being faced by uploading photographs of inaccessible places or where features of accessibility were not provided appropriately as per standards.

2. For this purpose, the following Officers are nominated as **"Nodal Officers"** to monitor the action taken by the concerned Authority/Owner on the issues raised by the Citizens through Mobile APP:-

- i. At the State level, the Director/Secretary/Additional Secretary as desired by concerned Administrative Secretary for their respective Department.
- ii. The Deputy Commissioner (DC) of District for Government Owned Buildings in the District.
- iii. Commissioner, Municipal Corporation / District Municipal Commissioner of Urban Local Bodies Department for Private Buildings or any other Building which comes under their jurisdiction.

3. In order to coordinate with various departments for timely disposal of issues/complaints. Deputy Director (DW), Social Justice and Empowerment Department shall be the Nodal Officer to look after the Sugamya Bharat APP at State level.

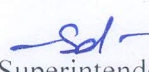

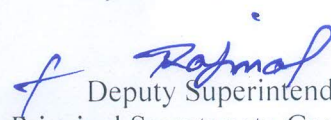
