# SHRESHTA scheme 2022-23

# **Guidelines for Spot Round for admission in SHRESHTA Schools**

#### 1. Objective:

The seats proposed to be filled under the SHRESHTA scheme by the selected CBSE affiliated Residential Schools (SHRESHTA Schools) but remained unfilled even after the 2 rounds of Web Counselling shall be offered to the SHRESHTA students for admission in class 9<sup>th</sup> or 11<sup>th</sup> through Spot Round as per the scheme given below.

The objective is to ensure that all the unfilled seats provided by the SHRESHTA schools are filled by the meritorious students who have secured Rank in the National Entrance Test for SHRESHTA (NETS).

# 2. Eligibility:

The following students are eligible for Admission through Spot Round:

- (i) Students having SHRESHTA Rank for admission in class 9<sup>th</sup> or 11<sup>th</sup> as the case may be,
- (ii) SHRESHTA Rank holder Students, in respect of whom PI reporting have not been done by schools till now, or
- (iii) Students, who have not reported to the allocated schools in Round-1 or Round-2, or
- (iv) Students, to whom no school has been allotted in Round-1 and Round-2 of e-Counselling

# 3. Details of Schools and vacant slots:

# 4. Modalities:

- a) SHRESHTA Students shall **report** physically at the SHRESHTA schools along with the copy of their certificates and the Rank Card of the NETS examination on 5<sup>th</sup> July 2022 (10 am to 2 pm).
- b) On <u>5<sup>th</sup> July, at 4 pm</u>, the school will publish the list of students offered admission <u>based on rank obtained</u> in the NETS exam.
- c) The selected students shall present themselves along with the parents/guardian and join the school on <u>6<sup>th</sup> July 2022</u>.
- d) Schools have to forward the details of students enrolled in their school in spot round through email on 6<sup>th</sup> July 2022 by 5 p.m.
- e) Guidelines for forwarding of information in respect of enrolled SHRESHTA students under spot round shall directly be shared with the Schools.
