Inviting Online Applications for National Entrance Test for Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA (NETS))-2023

Ministry of Social Justice and Empowerment has entrusted to NTA the responsibility of conducting **National Entrance Test for Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA (NETS))- 2023**.

Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA) provides for high quality education for meritorious Scheduled Castes (SCs) students only, in reputed residential schools. **Approximately 3,000 seats would be provided in class 9th and 11th in these schools.**

The **National Entrance Test for SHRESHTA (NETS)** will be an offline test conducted by the National Testing Agency (NTA) for selecting SC students for **admission in Class 9 and 11** whose parental annual income is up to ₹ 2.5 lakh. There is **no fee** for the examination.
