Ministry of Social Justice and Empowerment has entrusted to NTA the responsibility of conducting National Entrance Test for Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA (NETS))- 2023.

Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA) provides for high quality education for meritorious Scheduled Castes (SCs) students only, in reputed residential schools. Approximately 3,000 seats would be provided in class 9th and 11th in these schools.

The **National Entrance Test for SHRESHTA (NETS)** will be an offline test conducted by the National Testing Agency (NTA) for selecting SC students for **admission in Class 9 and 11** whose parental annual income is up to $\underbrace{?}$ 2.5 lakh. There is **no fee** for the examination.
