Scheme for Residential Education for Students in High Schools in Targeted Areas (SHRESHTA Scheme 2024)

Round 2 Counselling Eligibility & Process

1. Eligibility to Participate in Round 2 Counselling

Following types of Candidates will be eligible for Round 2 Counselling.

- **Group–I (No Seat Allotted in Round 1):** Eligible candidates, who have NOT been allotted any seat in Round 1, will be permitted to fill the fresh choices or modify their submitted choices (if any). Following types of candidates will be considered in this group.
 - **Fresh Candidates:** Eligible Candidates, who did not register in Round 1, can registered in 2nd Round of Counselling. For these new candidates Registration, choice filling and choice locking rules will be same as of Round 1 Counselling.
 - **Registered in Round 1 but not filled any choices:** Candidates, who registered in Round 1, but not filled any choice in Round 1. These candidates may fill the fresh choices. For these candidates, choice filling and choice locking rules will be same as of Round 1 Counselling.
 - **Registered, Filled Choices but not Allotted any Seat in Round 1:** Candidates, who registered in Round 1, filled the choices in Round 1 but not allotted any seat as per their submitted choices and seat intakes. These candidates may fill the fresh choices or modified their previously submitted choices.

During Round 2 login, these candidates will give the consent to fill the fresh choices and they'll be allowed to fill fresh choices. In this case, previously filled choices of these candidates will be treated as null and void.

Those candidates will not give the consent, their previously filled choices will be considered in Round 2.

- **Group–II (Seat Allotted in Round 1 and NOT submitted the willingness as FREEZE):** Those candidates, who had been allotted a seat in Round 1 and NOT submitted the willingness as FREEZE (No-Upgradation), will give the consent to fill the fresh choices and they'll be allowed to fill fresh choices. In this case, last allotted choice will be added at the last position of freshly submitted choices and previously filled choices of these candidates will be treated as null and void.

Those candidates, who will not give the consent, their previously filled choices will be considered in Round 2 Seat Allocation.

In this round a new seat may be allotted out of the choice preferences placed above previously allotted seat. In case no new seat is allotted, then their earlier allotted seat would be retained.

- **Group–III (Seat Allotted in Round 1 and submitted the willingness as FREEZE but NOT Reported at Allotted School):** Those candidates, who had been allotted a seat in Round 1 and submitted the willingness as FREEZE (No-Upgradation) but not Reported at Allotted School will give the consent to fill the fresh choices and they'll be allowed to fill fresh choices. In this case, last allotted choice will be added at last position of fresh submitted choices and previously filled choices of these candidates will be treated as null and void.

Those candidates, who will not give the consent, their previously filled choices will be considered in Round 2 Seat Allocation.

In this round a new seat may be allotted out of the choice preferences placed above previously allotted seat. In case no new seat is allotted, then their earlier allotted seat would be retained.

2. Non-Eligibility for Round 2 Counselling

The following types of candidates will not be eligible in round 2.

- **Seat Allotted in Round 1, Submitted the willingness as FREEZE and Reported at Allotted School:** Those candidates, who reported at allotted school after submitting the willingness, will not be allowed to submit fresh choices or modify their previously submitted choices. Their earlier allotted seat would be retained.
