Whereas, the officer has not submitted any progress report to the higher authorities in the last two years; and

Whereas, vide this office letter No: LA(TRM)UTL/2019 dated: 06-01-2020, a show cause notice has been served to the Assistant Director Tourism, Zanskar regarding non submission of progress report regarding promotion of Tourism in Zanskar region; and


Whereas, the officer has been given seven days period from the date of issue of show cause notice to explain his position; and

Whereas, the officer has failed to submit the reply to the show cause notice within the prescribed time limit, which has been viewed seriously; and

Now therefore, pending inquiry into his conduct Mr. Tundup Namgyal, Assistant Director Tourism, Zanskar, is hereby placed under suspension with immediate effect.

The officer shall remain attached with the Director Tourism UT-Ladakh during the period of suspension.

During the suspension period of the officer, the Assistant Director Tourism, Kargil shall look after the routine work of Assistant Director Tourism, Zanskar in addition to his own duties.
