Sub: PUBLIC TRANSPORT: Precautionary Measures - COVID-19

ORDER

With a view to containing the spread of Novel Corona Virus, (COVID-19) it is hereby ordered that the following precautionary and containment measures shall be adopted by the District Administrations of Kargil & Leh; all concerned officers of the Transport Department; and stake holders connected with the passenger transport:-

1. Awareness/publicity about the importance of "social distancing" in controlling the spread of COVID-19 shall be carried out vigorously at nodal locations of public transport.
2. General public be advised through appropriate means to minimize frequency of travels, and cancel avoidable travel.
3. **Cleaning and frequent fumigation/sanitization in all public transport vehicles shall be ensured in coordination with the health department/Municipal Committees.**
4. **No standing of passengers in public transport shall be allowed. One-Seat-One-Passenger norm shall be enforced.**
5. Regular checking of the public transport by the enforcement team of the RTO/ARTO shall be conducted to ensure proper precautionary measures in public transport system.
6. Appropriate publicity and awareness programmes amongst the drivers, helpers, conductors about the precautionary measures to be followed to contain spread of Novel CORONA VIRUS, shall be conducted. All Transport Unions and stakeholders to be involved.
7. The Traffic Police shall ensure constant vigil and assist in enforcement of the above in coordination with the transport authorities.


