

THE ADMINISTRATION OF UNION TERRITORY OF LADAKH SOCIAL WELFARE DEPARTMENT Civil Secretariat, Ladakh

NOTIFICATION Ladakh, 23rd April, 2020

S.O.14:- In exercise of the powers conferred by section 23 of the Jammu and Kashmir Reservation Act, 2004 as extended to the Union Territory of Ladakh by the Jammu and Kashmir Reorganization Act 2019, and in accordance with the Rights of Persons with Disabilities Act, 2016, the Administrator of Union Territory, Ladakh, hereby makes the following amendments in the Jammu and Kashmir Reservation Rules, 2005, namely,—

- 1. In Rule-1. For 'Jammu and Kashmir', substitute 'Union territory of Ladakh'.
- 2. In Rule-2.
- (i) In clause (i), for 'Jammu and Kashmir', substitute 'Union territory of Ladakh'.
- (ii) in clause (xii), for 'Jammu and Kashmir', substitute 'Union territory of Ladakh'.
- 3. In Rule-4.
- (i) In clause (a), for '8%', substitute '1%'.
- (iii) in clause (b), for '10%', substitute '45%'.
- (iii) in clause (c), -
 - (a) in sub-clause (i), for 2%', substitute 'Nil'.
 - (b) in sub-clause (ii), for '3%, substitute '4%'.
 - (c) in sub-clause (iii), for '20%', substitute 'Nil'.
- (iv) in clause (e), for '3%', substitute '4%.
- (v) for Explanation (C), substitute the following, namely, -

Explanation (C): - For the purpose of clause (e), reservations in recruitment shall be available for physically challenged persons for services and posts specified in section 34 of the Rights to Persons with Disability Act, 2016 to the extent specified therein, i.e.,

Disability	Act, 2010 to the extent specimes the end, many	40/
(a)	blindness or low vision;	1%
(b)	deaf and hard of hearing;	1%
(c)	locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;	1%
(d)	autism, intellectual disability, specific learning disability and mental illness; and	1%
(e)	multiple disabilities from amongst persons under clauses (a) to (d), including deaf-blindness.	

3. In Rule-5. For sub-rule (1), substitute the following sub-rule, namely,-

'(1) With a view to giving effect to the reservation herein before provided in this part, the appointing authority shall, in respect of each service, class, category and grade in the services and posts in the Union territory of Ladakh, maintain a roster of 100 vacancies in the form given herein after:

- **8. In Rule-28.** (i) Omit 'lay it on the table of each House of State Legislature after which it shall be'.
 - (ii) for 'published in the Government Gazette', substitute 'publish it in the Official Gazette'.
- 9. In Rule-29 Omit.
- 10. In Rules-35. For 'Government', substitute 'Administration of Union territory of Ladakh'
- **11. In Rules-36.** (i) For 'Government', substitute 'Administration of Union territory of Ladakh'.
 - (ii) For explanation, for 'the Government shall mean the Government', substitute 'the Administration of Union territory of Ladakh shall mean Administration'
