**Subject:- Furnishing of information regarding tentative seniority list, categorization of vacancies and status of Recruitment Rules of all departments in UT Ladakh.**

The exercise of apportionment of employees in terms of section 89 of the J&K Reorganization Act, 2019 is under process with the Advisory Committee on Assets and Liabilities constituted by the Ministry of Home Affairs, Government of India.

**2.** In the mean time in regard to the above it is significant to have on record in the General Administration Department, Ladakh consolidated information on the issues as noted below:-

- i. Tentative seniority list of all employees of Union territory of Ladakh, who have opted for UT Ladakh in pursuant to section 89 (2) of the J&K Reorganization Act, 2019 at the time of furnishing of option to the UT of J&K..
- ii. Details of vacancies post wise categorized as Direct Recruitment (DR) and Promotion quota (P) of all the departments in UT Ladakh.
- iii. Status of updated recruitment rules/ proposals for reorganization of departments in respect of which review has already been undertaken by the Administrative Secretary, Law Department in his capacity as Nodal Officer (Law), Ladakh.

**3.** Now keeping in view the availability of above details, being pre requisites for compilation in connection with apportionment of employees, therefore the same needs to be obtained from all departments accordingly.

**4. The above instructions are brought to the notice of all concerned Deputy Commissioners/ SSPs/ Directors for furnishing requisite details as at S.No.2, to this department within a period of five (5) days positively, treating the matter as most urgent.**


