**Subject: Dr. Rabiya Bano V/s UT of Ladakh & Ors.**

**ORDER NO. 1-LA (LAW) OF 2020**

**Dated: 11-07-2020**

Whereas, in pursuance to order passed by the Hon'ble Central Administrative Tribunal in OA No. 062/330/2020 dated 03.06.2020 titled Dr. Rabia Vs Union Territory of Ladakh, a representation is received from Dr. Rabiya Bano, Medical Officer, District Hospital Kargil;

Whereas, transfer proposal of Dr. Rabiya Bano was submitted by the Chief Medical Officer Kargil, vide Order No. CMO-K/MF-Dr/2019/7304-08 dated 12.12.2019 wherein, Dr. Rabiya Bano, Dr. Abdul Jalil (husband of Dr. Rabiya Bano), Dr. Tsering Tashi and Dr. Nawang Chosdon was proposed to transfer to their native place, CHC Padum Zanskar;

Whereas, directed on the approval of the Commissioner Secretary, H&ME Department UT Ladakh and on the basis of proposal submitted by Chief Medical Officer Kargil a transfer Order was issued by the the Director Health Services Ladakh, vide Order No. DHS/TRF/GAZ/2020/562-71 dated 19.05.2020 wherein, Dr. Tsering Tashi, Dr. Abdul Jalil & Dr. Rabiya Bano were posted to CHC Padum Zanskar;

Whereas, Directorate of Health Services, Ladakh had issued a partial modification of transfer vide Order No. DHS/TrF/Gaz/2020/599-608 dated 23.05.2020 wherein, Dr. Tsering Tashi, Dr. Stanzin Angmo & Dr. Rabiya Bano were posted to CHC Padum Zanskar;

Whereas, as per the transfer of Dr. Nawang Chosdon is concerned, he approached Directorate Health Service through Commissioner/Secretary H&ME Department Ladakh with request to transfer near Leh on the plea that his wife and son has been suffering from chronic Hepatitis-B for last six years and statement of doctors was submitted as documentary proof;

Whereas, as per certificate issued by the Chief Medical Officer Kargil, vide: CMO-K/PF-Dr/2019/0542 dated: 03.01.2019 Dr. Nawang Chosdon has served 15 years in Zanskar, 11 years as medical officer at CHC Padum/NT PHC Karsha and 4 years as medical officer on adhoc basis while as per Letter No CMO-K/Court-case/2020/3728-31 Dated 27.6.2020 by Chief Medical Officer Kargil, Dr Rabiya Bano has served 7 years in Zanskar;

Whereas, on the basis of the above facts the request of Dr. Nawang Chosdon for posting to Leh District instead of Zanskar was approved and that there is no case of Nepotism/Favoritism;



Whereas, Dr. Abdul Jalil was also proposed to transfer to CHC Padum Zanskar, which was later modified;

Whereas, Dr. Rabiya Bano is a permanent resident of village Padum Zanskar and Dr. Abdul Jalil (husband of Dr. Rabiya Bano) is posted at District Hospital Kargil and at present is working as Nodal Officer dedicated COVID-19 Hospital Kargil;

Therefore, after considering the above mentioned facts, in view of the demand received from the public representatives and due to shortage of doctors at Zanskar Sub Division, the request of Dr Rabiya Bano cannot be considered at present which is also in the interest of the administration and general public at large. Dr Rabiya Bano is hereby accordingly informed of aforementioned reasons.


