The Candidates having attained the minimum age of 14 years, as on 1st June 2020, with no bar for upper age can apply. 1. Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self-

2. On successful completion of training in affiliated Trades running under NCVT, certificate will be awarded by National Council for Vocational Training, GoI.

3. On successful completion of training in Trades running under SCVT, certificate will be awarded by State Council for Vocational Training, J&K.

4. Candidates who have already undergone training in any of the Trades in any ITI can apply for admissions in another trade two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.

5. The Candidates belonging to Nobra/Durbuk/Nyoma/Zanskar Subdivisions can also obtain the application form, from their respective SDM Offices against cash payment of Rs 40 and shall deposit the duly filled application forms along with the requisite documents either directly to the concerned

ITI or to the concerned SDM Office.

6. The respective SDM(s) mentioned at para 5 above, shall submit the duly filled application forms received from the candidates along with the requisite documents (with a consolidated list of candidates) to the concerned ITI by 09.09.2020 (after which no forms will be entertained).

receipts) to the concerned ITIs with the list of candidates.
