Subject:- Celebration of the Constitution Day on 26<sup>th</sup> November, 2020-instructions thereof.

Circular No. 16- LA (GAD) of 2020. Dated: 25.11.2020

On 26<sup>th</sup> of November, 1949 the constitution for the Country was adopted, making the day very sacrosanct for the Country as a whole.

To celebrate the auspicious day and sensitize people to the values enshrined in it, it has been decided that the ceremonies of reading of the Preamble to the Constitution shall be organized within the Government offices/institutions and other establishments in the Union territory of Ladakh. The reading out activity shall be held along with the live telecast of the recital of same by the Hon'ble Prime Minister of India on 26<sup>th</sup> of November,2020 at 11.00 a.m. The copy of the Preamble is also enclosed.

Divisional Commissioners/ /Deputy Commissioners/ Heads of the Departments and Managing Directors of all PSUs/Corporations are directed to organize Preamble reading ceremonies on similar lines in their respective offices/locations, adhering to all SoPs in view of COVID-19 pandemic. Similar programs shall be organized in Council Secretariats of LAHDC Leh & Kargil.

The Home Department, Department of Rural Development & Panchyati Raj, Revenue Department and Housing & Urban Development Department shall also issue necessary instructions in this regard to their subordinate offices/organizations viz; Police Department, Block Offices/ Tehsil & Sub-divisional Offices/Panchayats and Municipal Corporations respectively to organize the said event on similar pattern on the scheduled date and time.

Main function in Secretariat shall be held in Conference hall of Advisor and all officers/officials will join through weblink to be circulated by NIC.


