## It is further ordered that:

1. Scrap value upto Rupees Two lakh may be sold on a limited tender basis to locally known scrap dealers of relevant category.

- 2. Sale through e-auction portal or e-tender for disposal or traditional public auction may be resorted to for scrap value above Rs Two lakhs.
- 3. E-auction should be preferably made for such disposals using the e-auction platforms of NIC.
- 4. Instructions related to surplus, obsolete and unserviceable stores for disposal contained in GFR 2017 should be strictly adhered to.
- 5. The statement should be authenticated by a certificate under seal and signature of the constituted Committee.
- 6. Manual for procurement of Goods 2017 envisaging disposal of scrap goods needs to be adhered to by the constituted Committee.
- 7. This issues with the concurrence of Finance Department vide their U.O. No. Comm/Secy/UTL/3819 dated 26/11/2020.
