**The terms of references of the BLC shall be:**

- The Block Level Committee would be responsible for preparing the plan of the identified Minority Concentration Blocks (MCB).
- The committee would also be responsible for monitoring this program at the block level.
- The plan for Minority Concentration Block will be prepared by the local body and will submit its plan to District Level Committee for Prime Minister's New 15 Point Program.



- d) The committee would prepare the plan (comprising different projects needed on the basis of base line survey and on felt needs) for identified Minority Concentration Blocks (MCB).
- e) Deputy Commissioner concerned shall issue separate order constituting the BLC for each block by nominating the non-official member and NGO representatives.


