Ladakh, the 11th February, 2021

S.O. 04 . - In exercise of the powers conferred by sections 23 and sub-section (2) of section 9 of the Jammu and Kashmir Reservation Act, 2004 (14 of 2004) read with paragraph 8 of the Jammu and Kashmir Reorganization (Removal of Difficulties) Order, 2019 and all other enabling provisions in this behalf, the Administration of Union territory of Ladakh hereby makes the following amendments in Jammu and Kashmir Reservation Rules, 2005, namely.-

Throughout the rules, for "Government" substitute "Administration of Union territory of Ladakh", except in preamble.


Throughout the rules, for "Jammu and Kashmir Government Gazette" or "Government Gazette" substitute "Official Gazette".

After rule 15, insert rule 15A as follows;

"15A Distribution and allocation of Central pool MBBS/BDS seats allotted to the Union territory of Ladakh under deficient medical education category. - (1) For Central pool MBBS/BDS seats allocated to Union territory of Ladakh under deficient Medical Education Category as nearly as possible 50% of seats available in that category shall be reserved for Scheduled Tribes of Union territory of Ladakh.

(2) The selection of candidate and allotment of MBBS/BDS seats to various colleges shall be in accordance with the procedure prescribed by the Administration of Union territory of Ladakh."
