## Notification Ladakh, the 24<sup>th</sup> February, 2021

**S.O. 05.-** In exercise of the powers conferred by sub-section (1) of section 6 of the Legal Services Authorities Act, 1987 (No. 39 of 1987) read with rule 3 of the Union territory of Ladakh Legal Services Authorities Rules, 2020 notified vide S.O. 13, dated 09.04.2020, the Hon'ble Lieutenant Governor of Union territory of Ladakh, in consultation with the Hon'ble Chief Justice of the Common High Court for the Union territory of Jammu and Kashmir and Union territory of Ladakh, hereby constitute the Union territory of Ladakh Legal Services Authority to exercise the powers and perform the functions conferred on, or assigned to the said Authority under the Act.
