 - b. *Not confer any superior claim or right upon them at the time of regularization and shall be subject to the outcome of the case(s) if any, pending adjudication in any court of law.*
2. *The salary of the officers placed on an officiating basis to look after the assignment of principal shall be drawn subject to the satisfactory vigilance clearance received in their favour.*


