Sanction is hereby accorded to the constitution of District Skill Committees (DSC) to take forward the various activities and interventions under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), and to ensure quality, consistency and convergence in the skill ecosystem of the District, besides generating awareness of various initiatives launched by the Ministry of Skill Development and Entrepreneurship, Government of India. The DSC shall comprise of the following officers of the respective district:-

The Chairperson of the DSC will have the authority to co-opt any other member or invite special invitees to the meeting of the DSC as and when need arises.

The committee shall work as District level focal point and local facilitator for ensuring and sustaining skill nourishing initiatives at the district level. The broad areas of activities of the committee shall be as under:-

- i. Asses the nature and magnitude of the skill gap across the districts and suggest appropriate measures in terms of vocational or other training to bridge the gap.
- ii. Generate awareness among the unemployed youth about the industry demand for various vocations/trades, project future demand of industry at district level and suggest/explore methods in order to increase livelihood opportunities across the districts and facilitate enhanced job creation.
- iii. Review the infrastructure, machinery available with various vocational training providers engaged in implementing Central and UT Administration schemes (like Government and Private ITIs, PMKVY and PMKK centers, NSDC centers etc.) across the District.
- iv. Coordinate the efforts of various Government Departments and industry in the District for building and nurturing a valuable skill base having regard to the local art, crafts and trade.
- v. Training and creating a pool of trainers in various trades across the districts to facilitate the implementation of various skill development initiatives of the Central and UT Administration.
- vi. Mentoring and nurturing of new and relevant vocational institutes by seeking inputs from the local labour market of the District and proposing appropriate course designs in consultation with other vocational institutes especially ITIs.
- vii. Organizing and providing infrastructure and other facilities for facilitating Kaushal Melas to promote skilling opportunities and facilitating Rozgar melas for placement of skilled youth in the District.
- viii. Organizing and conducting counseling sessions for skilled youth and vocational graduates of the district with regard to awareness of various schemes and programmes of the Central and UT Administration and the process of registration of portals like National Career Services (NCS) portal, Labour Market Information System (LMIS) portal.
- ix. Organizing Convocations for vocational graduates across the District to ushering them a sense of pride and accomplishment thereby encouraging the concept of self-employment.
- x. Generating awareness about financial incentives and schemes available for financing of local entrepreneurship.


- xi. Monitoring progress of apprenticeship schemes and ensuring convergence of funds from various Central and UT Administration schemes for improving the skill ecosystem.
