- iii. Develop Standard Operating Procedure for collection and utilization of UCO.
- iv. Prepare comprehensive plan for stakeholder engagement.
- v. Prepare citizen charter to expedite clearance at Central & State Level agencies for establishing UCO collection, transport and its safe disposal.
- vi. Develop platforms for stakeholders to discuss issues related to UCO disposal and collection.
- vii. Create enabling mechanism and eco-system for developing sustainable supply chain for UCO collection and further its availability to biodiesel plants.
