Instances of various traffic/transport related violations/offences like **plying of un-registered , overloaded motor vehicles and motors vehicles without pollution certificates and High Security Registration Plates** on the roads of Ladakh have been brought to the notice of the Transport Department.

In terms of the notification S.O.10 dated:- 06.03.2020, the administration of the Union territory has specified various Compounding Authorities to compound such offences/violations under various sections of the Motor Vehicle Act,1988 within their territorial jurisdictions (Copy enclosed).


All the Compounding Authorities are therefore enjoined upon to exercise their powers to compound any such traffic/transport related offences/violations in their respective jurisdictions as specified in the above said notification and penalties/punishments as per relevant sections of the Motor Vehicle Act,1988 be imposed strictly. The Compounding Authorities shall also furnish a fortnightly report to this Department through the Regional Transport Officer,Ladakh for onward submission to the office of Hon'ble Lieutenant Governor


