S.O.07. – In exercise of the powers conferred by section 3 of the Jammu & Kashmir Motor Vehicle Taxation Act, 1957 (XXVI of 1957) as adopted vide S.O. 3775 (E) dated:-23.10.2020, the Administration of Union territory of Ladakh hereby directs that:-

- i. The road/token tax in respect of new motor vehicle(s) using any public road in the Union territory of Ladakh shall be levied at the rates indicated against each as under:—

S.No.	Type of vehicles	Percentage
1.	Two wheelers with cost upto ₹2.00 lakh.	One time tax @3% of the cost of vehicle excluding GST.
2.	All Motor Vehicles with cost upto ₹10.00 lakh.	One time tax @6% of the cost of vehicle excluding GST.
3.	All Motor Vehicles with cost of above ₹10.00 lakh.	One time tax @9% of the cost of vehicle excluding GST.

- ii. The road/token tax in respect of motor vehicle registered/bought from other states/Union territories whose age is only 09 years or less at the time of re-registration in the Union territory of Ladakh shall be levied on pro-rata basis of the life of the vehicle which is 15 years at present and the tax on vehicle whose age is 10 years or more at the time of re-registration in the Union territory of Ladakh shall be the same as applicable to new vehicle as per para (i) above.
