

Public Notice

Inviting Applications for registering as Recognised Qualified Person (RQP)

Since Mining Plan is a pre-requisite to the grant of Minor Mineral Concessions like (Mining Lease, Quarry Licence, Short Term permit/Disposal Permit) and no person shall be granted any Minor Mineral Concession in any area unless a Mining Plan is submitted and approved under the provisions of **J&K Minor Mineral Concession Rules, 2016 notified vide SRO-105, Dated 31-03-2016 and amended vide SRO 135 dated 22-03-2017 and SRO 267, Dated 03-07-2017/NGT guidelines** and further no person shall commence Mining operations for Minor Minerals in any area except and in accordance with a Mining Plan approved under these rules.

Accordingly every Minor Mineral Concessionaire shall prepare a **Mining Plan along with the Mine Closure Plan (Progressive and Final)** and in this behalf erstwhile J&K state has already registered near about 20 persons as Recognised Qualified Person (RQP's). However, as per the records available no person from UT of Ladakh is a registered Recognised Qualified Person. So keeping in mind the present scenario when a huge number of qualified persons/youth are unemployed and in search of job as such applications are invited **from the persons of Ladakh** region to get their selves registered with the Geology & Mining Department as a Recognised Qualified Person (RQP).

However, no person shall be registered as a RQP by the Director Geology & Mining/Secretary to Government Industries & Commerce UT of Ladakh unless he possesses:-

1. Post Graduate degree in Geology granted by a University/ a Degree in Mining Engineering besides possessing a professional experience of Five years of working in a supervisory capacity in the field of Mining or Mineral administration after obtaining the Degree or
2. Three year full time diploma certificate in Mining Engineering by recognised Board/ University and possessing professional experiences of 10 years of working in a supervisory capacity in the field of Mining or Mineral administration after obtaining the Diploma.
3. Any person possessing the above qualification and experience as prescribed under Rules may apply to the Director Geology & Mining Ladakh for registration as a RQP along with a fee of 10000/rupees with in a period of 10 days from the date of issuance of this notification.

The Director Geology & Mining Department Ladakh /Secretary I&C UT of Ladakh may after making such inquiry grant or refuse registration. The registration granted so shall be valid for a period of 10 years and the registration is renewable from time to time for further period of 10 years.
