### **TERMS AND CONDITIONS**

1. The intending bidders will be allowed to participate in the process of tendering/bid only on the production of earnest money for an amount of 43,000/=(Rupees forty three thousand only)for toll Post of Srinagar Leh Road in the shape CDR/FDR drawn on any branch of nationalized bank pledge to the Executive Officer Municipal Committee Leh which should be enclosed while participating in the auction. In absence of the same, the bid will be rejected our rightly.

2. The successful tender/bidder will have to pay the 50% of the total value of bid if his offer is found to be the highest and accepted for the job by the Municipal Committee, Leh within the 5 days through cheque or cash, and the remaining 50% shall be deposited within next 30 days. The successful bidders have to furnish the Bank Guarantee to the tune of bid amount. In case the higher bidders fail to pay the amount specified above, the bid shall be offered to 2nd highest bidder on spot on the risk and responsibility of 1st higher bidder.

3. The successful tender is bound to use the entry fee coupon book of Municipal Committee, Leh only. Which shall be arranged by him within 2 days from the date of issue of letter of intent as per the specification approved by Municipal Committee, Leh and shall be got entered in the stock book of Municipal Committee, Leh.

4.The successful tenderer will himself be responsible for the collection of entry fees at collection centre with effect from the date road is declared officially open to the date and it is declared officially close during the year 2021, with scope of extension keeping in view by Municipal Committee, Leh/ district administration.

5. In case of any untoward/undesired commission or act/law and order situation/in police case/complaints etc. by the successful tenderer or any of his representatives during the contract period ,the dispute shall have to be resolve by the successful tenderer/bidder himself. Municipal Committee, Leh shall have no responsibility in this account toward allottee in this regard.

6. The successful tenderer shall have no authority to claim or collect the entry fee before or after time specified in clause 4.

- 7. The successful tenderer or bidder will arrange for basic facilities like accommodation of his staff, electricity, drinking water and sanitation under close supervision of Municipal Committee Leh for the same.
- 8. The successful tenderer or bidder shall charge the entry fee from the different types of vehicles entering Leh town (Only one side) as per following pattern.

Excluding Army, Beacon/Gref/Police/Govt/Semi Govt Vehicles and also light pvt of Leh District to be assessed by the Municipal Committee, Leh.

- 9. In case the successful tenderer/bidder violates or over charge entry fee the Municipal Committee, Leh shall cancel the contract and forfeit the CDR together with the amount deposited in Municipal Committee, Leh from time to time also initiate legal proceedings against the allottee, besides imposing heavy fine.
- 11. The employees of successful tenderer/bidder posted at Toll Bar shall have to wear proper uniform as per the specification/design approved by the Municipal Committee, Leh all times. The uniform shall be provided by the successful tenderer /bidder himself.
- 12. The employees posted at Toll post must be well behave, well mannered and polite and must not cause any kind of inconvenience to tourist/visitors, character certificates NOC from their respective police station be provided to Municipal Committee, Leh their working at entry fee point along with bio data and photographs.
- 13. In case of any unavoidable circumstances hartal/ strike etc. The receipt of tenders will be conduct on next working day as scheduled venue and times as deemed fit by the Municipal Committee, Leh.
- 15 The successful tenderer / bidder will have to execute an agreement with the Executive officer Municipal Committee Leh. Within 3 days from the date of formal allotment.
- 16. The earnest money of Rs. 43,000/= shall remain with the authority and will be released on the expiry of the contract.
- 17. Starting bid /tender for the collection points will be of (Rs. 21.50 lacs only).

- 18. The intending parties may inspect the spot where from the entry fee is to be collected for their assessment before offering the tender/bids.
- 19. The Executive Municipal Committee, Leh reserves the right to accept or reject any tender /bid without assigning the reason thereof.
- 20. The successful bidder has to deploy sufficient staff at toll post in order to avoid any kind inconvenience to motorists.
- 21. The rates offered should include all applicable taxes.
- 22. The applications forms/terms and conditions shall be made available to the eligible tenderer bidder from the office of the undersigned from the date of issue of tender notice to 16/4/2021 during office hours up to 1:00 PM on cash payment of Rs 2000 non refundable.
- 23. The tender/application from (s) duly filed and affixed with revenue stamps worth Rs. 6/- should be addressed to the Executive, Officer Municipal Committee Leh.
- 24. Leh town is no polythene Zone declared by the LAHDC, Leh. The successful bidders/tenderer will have to assist Municipal Committee, Leh in maintaining a check on import of polythene in to Municipal Jurisdiction by conducting spot check of load carriers in consultation with Municipal Committee, Leh staff at any time desired.
- 25. The defaulter of Municipal Committee, Leh other Govt departments shall not be allowed to participate in the bid/tenders.
- 26. The Municipal Committee, Leh reserves the right to include and exclude any condition at the time of auction.
- 27. Any doubt in the terms & and conditions shall have to be clarified before the date of auction, and no clarification shall be entertained at the time of auction.
- 28. No excuses of any nature shall be entertained by the committee.
- 29. The committee will pay surprise visit to the toll posts and if any violation of the contract is found the contract will be cancelled thereof.
- 30. No Compensation in shape of Extension of Contract Period for the next year or in any Monetary concession shall be given to the allottee in case of any untoward situation arise during the contract period.
