Subject: - Grant of Ex-gratia relief in favour of NoKs of Army and CAPFs Personnel in the Union Territory of Ladakh-regarding.

**Order No.13-Home of 2021**  
**Dated: 25-05-2021**

1. Sanction is hereby accorded to the grant of Ex-gratia relief in favour of NoKs of Army and CAPFs Personnel killed or permanently/ partially disabled in action or in course of performing duty attributable to the breach of law and order or any other form of civil commotion in the Union Territory of Ladakh as under:-

2. **Next of Kins (NoKs):** Would mean the surviving dependents of the deceased as certified by the District Collector concerned.

3. The Next of Kin of the deceased/ disabled person shall apply to the concerned Commanding Officer within one year. Provided that for such cases which occurred between 31-10-2019 and the notification of this order, the one year period shall be counted from the date of notification of this order.

4. The Disability Certificate should have been issued by an authority in accordance with Notification No. G.S.R. 2 (E) dated 30.12.2009 of Ministry of Social Justice and Empowerment, Government of India.

5. The Commanding Officer of the concerned unit shall forward the Ex-gratia case to the Home Department within one month of the receipt of application for grant of Ex-gratia complete in all respects.

6. The Administration in the Home Department shall be the competent authority to sanction the Ex-gratia amount.

7. The amount shall be drawn by the Senior Accounts Officer, Home Department for disbursement to the concerned beneficiary by debit to the Major Head 2052-Other charges.

8. The Ex-gratia relief would be payable to the Next of Kins of Army/ CAPFs Personnel serving in the Union Territory of Ladakh subject to the fulfillment of all the standing instructions issued by the Central Government from time to time.

9. This issues with the concurrence of Finance Department conveyed vide e-File No B-13011/1/2021 dated 19-05-2021.
