- i. UT/SLSC shall recommend DPRs for approval of the monitoring Committee, after vetting the physical works covered under the project and ensuring adequacy of upstream network, commensurate with the proposed distribution network and availability of adequate power supply to cater to the load demand of the project area.
- ii. Ensuring that there is no duplication/ overlapping of works with any other Government of India schemes like RGGVY, NEF etc.
- iii. Monitoring progress, quality control and resolve issues relating to implementation of sanctioned projects viz. allocation of land for substations, right of way, forest clearance, railway clearance, safety clearance etc.
