Under the aegis of the committee the restoration and conservation works of water bodies and rain water harvesting related activities shall be carried forth based on the propositions formulated and recommended by Central Pollution Control Board (CPCB) in compliance to aforesaid orders of Hon'ble NGT.

5. Assess, review and coordinate the implementation of directions of Hon'ble NGT and formulate polices for overall regulation of water bodies in the UT of Ladakh.


