Sanction is hereby accorded to the constitution of a District Environment Committees, comprising the following, to oversee the preparation and implementation of District Plans and other Rules in the UT of Ladakh.

- i. The committee shall oversee the preparation and implementation of the District Environment Plan for operation in the district.
- ii. The Chairman of the Committee shall convene at least two meetings in every month and place the minutes on the official website of the district, under an intimation to the Advisor UT Ladakh, Housing and Urban Development Department and the Forest Department (Nodal Department).

- iii. The committee shall be responsible for enforcement of Environmental Norms at the ground level, besides the issues reflected in O.A No. 606/2018, including.
 - a. Solid Waste Management
 - b. Bio-Medical Waste Management
 - c. Plastic Waste Management
 - d. Construction and Demolition Waste (C&D) Management
 - e. Pollution abatement in non-attainment cities
 - f. Control in identified polluted river stretches
 - g. Industrial Pollution control
 - h. Sewage Treatment
 - i. Regulation of Sand Mining
- iv. The committee may co-opt any other member(s) or expert(s) in the implement of the directions of the Hon'ble NGT passed in different orders.
- v. This committee shall be deemed to have been constituted under Rule 12 of the Solid Waste Management Rules, 2016, and Rule 12 (4) of Bio Medical Waste Management Rules, 2016 and for issues reflected in the ToR above.
