- i. To oversee the implementation of National Land Records Modernization Programme (NLRMP) in its entirety.
- ii. To shall ensure coordination among all the concerned departments as well as between the various units of the implementing departments.
- iii. The Financial Commissioner, Revenue shall take necessary steps for registration of the society, and for opening of account under the Centrally Sponsored Scheme (CSS), strictly in accordance with the guidelines circulated by the Department of Land Resources (DoLR), Ministry of Rural Development, Govt. of India on the subject matter; and
- iv. Entire recurring and non-recurring expenditure shall be met out of the Central Assistance.


