S.O. 36 In exercise of the power conferred by section 25 of the Jammu and Kashmir Excise Act, 1958, read with S.O. 3775(E) dated 23.10.2020, and all other enabling provisions in this behalf, the Administrator of Union Territory of Ladakh, hereby makes the following amendments in the Jammu and Kashmir Liquor License and Sale Rules, 1984 namely:—


