The appointee(s) shall report to the undersigned within a period of 21 days from the date of issuance of this appointment order. In case of failure to join within the stipulated period, their appointments shall be deemed to have been cancelled without any further notice.

The appointee(s) shall be on probation for a minimum period of two (02) years and shall abide by the rules/orders governing the probation period from time to time. He shall be allowed to join only on production of the following certificates (in original) to be verified subsequently: -

- 1) Academic / Technical Qualification Certificates, which will also include whether these Certificates are approved for employment in Ladakh.
- 2) Matriculation /Date of Birth Certificate.
- 3) Health Certificate from the concerned Chief Medical Officer of the District.

- 4) Permanent Resident Certificate / Resident Certificate as prescribed.
- 5) Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been availed by the appointee(s).
- 6) Relevant Category Certificate.
- 7) Character / Antecedent Certificate.
- 8) Any other relevant document as required under rules.

The appointment of the above candidates, as Junior Assistant in Public Works (R&B) Department, shall further be subject to the following conditions that:-

- i) The appointee(s) shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from the CID Wing, Ladakh, they shall have no right to claim their appointment as Junior Assistant in the Public Works (R&B) Department, and their appointment, as such, shall be deemed to have been cancelled ab-initio;
- ii) Verification/ genuineness of the qualification, reserved category certificate. recognition of the Computer Institute etc from the concerned issuing authorities.

The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory report in respect of (i) and (ii) above is received in their favour; and

If, on verification, the certificates produced by the appointee(s) proved to be fake or forged, their appointment shall stand also cancelled ab-initio; and

The appointment of the above candidates shall be governed as per S.O 194 Dated 17<sup>th</sup> of June, 2020 read with Circular No. 09-LA(GAD) of 2020 Dated: 25.09.2020; and

The appointment and other terms & conditions of service of the above candidates shall be governed as per rules notified and applicable in the Union Territory of Ladakh from time to time; and

The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by the appointee(s) in the selection list prepared by the J&K Services Selection Board; and

The appointee(s) shall qualify the Secretariat Assistant Training Course / Other Mandatory Course as prescribed during the period of probation; and

The appointment of the above candidate(s) shall be subject to outcome of writ petition(s), if any, pending before the Competent Court of Law.


