The placement & issues related to inter-se seniority shall be subject to the outcome of writ petition(s), pending, if any, before any competent Court (s) of Law, and finalization of seniority list consequent upon the allocation of Officials to the UT of Ladakh under section 89 of J&K Re- Organization Act 2019.

And any official allotted to the UT of Jammu and Kashmir from the UT of Ladakh or vice versa, at a later date after final apportionment, shall be placed above the next junior official in the last final seniority list and that the placements will not create any sort of preferential right of any official for holding higher post.

Further the adjustment Order of the above Officials shall be issued separately.


