The UT Level Vigilance and Monitoring Committee shall meet at least twice in a calendar year, in the month of January and July to review the implementation of the provisions of the Act, scheme for the rights and entitlement of victims and witnesses in accessing justice, as specified in sub-section (11) of section 15A of Chapter IV A of the Act, relief and rehabilitation facilities provided to the victims and other matters connected therewith, prosecution of cases under the Act, role of different officers or

agencies responsible for implementing the provisions of the Act and review of various reports received by the UT Administration including that of the nodal officer and special officer.
