Subject:- Nomination of Nodal Officer under the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995

Order No:- 230 -LA (GAD) of 2021

In pursuance of Rule 9 of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995 as amended from time to time, sanction is given for the nomination of Secretary, Social & Tribal Welfare Department as Nodal Officer for co-ordinating the functioning of the District Magistrates and Superintendent of Police, investigating officers and other officers responsible for implementing the provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989.

It is further provided that the Nodal Officer by the end of every quarter shall review:-

- i) the reports received by the UT Administration under sub-rule (2) and (4) of rule 4, rule 6 and clause (xi) of rule 8;
- ii) the position/status of cases registered under the Act;
- iii) law and order situation in the identified area;
- iv) various kinds of measures adopted for providing immediate relief in cash or kind or both to the victims of atrocity or his or her dependent;
- v) adequacy of immediate facilities like rationing, clothing, shelter, legal aid, travelling allowance, daily allowance and transport facilities provided to the victims of atrocity or his/her dependants;
- vi) performance of non-Governmental organisations, the Scheduled Castes and the Scheduled Tribes Protection Cell, various committees and the public servants responsible for implementing the provisions of the Act.
