4. The fund is utilized for the purpose for which it has been released during the current financial year 2021-22 and no diversion of funds for any other purpose is allowed at any level.
5. The implementing agency shall furnish physical/financial progress report and utilization certificate along-with audited statement of accounts/red accounts etc. after utilization of the funds.
6. The implementing agency shall maintain a separate cash book for the scheme.
7. The Sr. Accounts Officer with the Secretary, Rural Development & PR Department shall ensure transfer of funds to the tune of **₹45.00** lakh (**Rupees/forty/five/lakh/only**) from the RGSA account
