3. The availability of funds for the above purchases/procurements shall jointly be vouchsafed by the Sr. Accounts Officer with the Secretary, Transport Department, Directorate/Accounts Officer of the concerned Departments under Object Head MOV-SDP-2021-22.
4. No diversion of funds shall be allowed at any level.
5. That the above purchase does not involve creation of additional/extra post of Driver.

This issues with the concurrence of Finance Department conveyed vide letter of approval of Action Plan under reference above.


