The terms of reference of the Committee:-

- i. The committee shall collate all such proposals/ representations from all sections and after examining the legal, social, aesthetic, architectural and other aspects thereof submit its recommendation to the General Administration Department at such time interval deemed appropriate by the chairperson.
- ii. The recommendations shall thereafter be placed before the Hon'ble Lt. Governor in coordination with the Advisor to Hon'ble Lt. Governor, Ladakh in a time bound manner for appropriate decision.
- iii. The committee may take up any other matter relevant to and connected therewith or incidental thereto during its deliberations/ meetings for consideration of the competent authority.
- iv. The committee may co-opt experts as adhoc member(s) for any particular proposal and also co-opt member(s) from any Government department/ organization to participate in its deliberations.
- v. The committee shall be serviced by the Office of Divisional Commissioner, Ladakh.


