Ladakh Power Development department (L-PDD) has filed the Petition for approval of True-up of FY 2019-20 & FY 2020-21, APR of FY 2021-22, ARR and Tariff Determination Proposal for FY 2022-23 on **09.05.2022** in accordance with the JERC for UT of J&K and UT of Ladakh (Adoption of various Regulations of JERC for the state of Goa and UTs) Regulations, 2021 and Joint Electricity Regulatory Commission for the State of Goa and Union Territories (Generation, Transmission and Distribution Multi Year Tariff) Regulations, 2018 before the Joint Electricity Regulatory Commission for the UT of J&K and UT of Ladakh (the Commission)for deliberation and Orders under the provisions of the Electricity Act, 2003 to the extent applicable.

To recover the revenue gap to some extent as submitted above, the Petitioner has proposed an average tariff hike of **14.66%**. The projected revenue billed for FY 2022-23 at proposed tariff is Rs.6539.12 lacs. The proposed tariff would lead to increase in revenue billed by Rs. 7491.73 lacs.

- A. Time of Day (TOD): L-PDD has proposed to continue with the existing TOD tariff without any modification.
- B. kVAh Tariff: kVAh tariff is already being applied to HT PWW, LT Industrial supply (For consumers with connected load > 50 kW), HT Industrial supply, HT-PTU and Bulk supply consumers and now L-PDD has proposed to extend the kVAh tariff to following consumers:

- Non-Domestic/ Commercial-Metered Connection-Three phase- For all units
- State/ Central Govt department-11 kV supply & 33 kV supply and above
- LT Industrial supply-For consumers with connected load < 50 kW
- Electric Vehicles
- Traction

- C. L-PDD requested to grant regularization of the retail supply tariff charged by L-PDD to its consumers for the period from its date of incorporation till date or till the Commission approves the proposed tariff.

- D. L-PDD requests the Commission to approve the schedule of Miscellaneous Charges without any changes in existing charges.

- I. The Commission has directed to L-PDD to publish a Public Notice under Section 64(2) of the Electricity Act, 2003 inviting suggestions / objections from the public.
